

# Annual Internal Audit Report 2020/21

During the financial year ended 31 March 2021, this authority's internal auditor acting independently and on the basis of an assessment of risk, carried out a selective assessment of compliance with the relevant procedures and controls in operation and obtained appropriate evidence from the authority.

The internal audit for 2020/21 has been carried out in accordance with this authority's needs and planned coverage. On the basis of the findings in the areas examined, the internal audit conclusions are summarised in this table. Set out below are the objectives of internal control and alongside are the internal audit conclusions on whether, in all significant respects, the control objectives were being achieved throughout the financial year to a standard adequate to meet the needs of this authority.

## Internal Audit of Parish Accounts

In forwarding the documentation for audit the RFO alerted me to two issues relating to financial management (P4, Point B):

1. Some backing documents relating to payments were missing, all from early in the financial year. I am content this was an administrative error because all payments were approved at Council, presumably before the paperwork got mislaid; and payees and amounts were as expected from recollections of past audits. No further action.
2. The current account was overdrawn for a number of days in late February. The account was returned to credit when the RFO became aware and no penalty was applied by the bank. Minutes show this was reported to Council at the March meeting, although Council's agreement for the RFO to run a higher balance on the account [as the RFO related to me] is not. A sensible solution given the negligible interest rates on savings accounts, and one which should continue in future even if rates improve. No further action.

With this qualification, I am satisfied that the accounts have been kept in good order and managed in accordance with adopted standards and procedures throughout 2020/21.
