- 1. **To elect** a Chairman of the Council.
- 2. **To receive** the Chairman's declaration of acceptance of office, or if not then received, to decide when it shall be received.

The Breckland Environmental Protection Team (EPT) say that the Environment Agency (EA) have confirmed that the site has an Environmental Permit, and their Noise Management Plan states that feed delivery times should be between 07:00 and 23:00. The Planning Permission for the site did include a noise level condition, but the Permit and Noise Management Plan

would be the way of dealing with the complaint. However the EA has spoken with the company and so it is hoped this will have resolved the issue. If not the EPT need the resident to keep a record of dates and times to provide suitable evidence. The Clerk has advised the parishioner accordingly, and so far he says there has been no repetition.
